NOTIFICATION

With reference to **Notification No. COE/NTFCN/22/03/11-25/Vol.II/043** and **COE/NTFCN/22/03/11-25/Vol.II/044**, dated **03.11.2025**, it is hereby notified that the University shall conduct all **Term End Examinations** strictly as per the schedule already issued.

However, in view of the **Panchayati Raj Elections in Arunachal Pradesh**, the examinations scheduled on **15 December 2025** and **16 December 2025** stand **postponed**. The **revised dates** for these examinations shall be notified separately in due course.


Further, for the remaining papers, students who are **unable to appear** on the scheduled dates due to **Panchayati Raj Election** may apply for a **reschedule of their examination date**. Such students must submit the "**Application Form for Reschedule of Examination**", duly forwarded by the **Dean/Head of the concerned Faculty**, along with **supporting documents** (Election Duty Order/Appointment Letter issued by the competent authority).

Upon scrutiny of the applications received and **subject to approval of the Competent Authority**, the University may permit eligible students to appear in a **Special Examination** to be conducted in **January 2026**. **No additional fee** shall be charged for this rescheduled examination.

All concerned students are required to submit their applications to the Examination Branch on or before **01 December 2025 (Monday)**, **before 3:00 PM**, **by hand** submission only, and **in person** by the **concerned student**.
